- **b.** Under 'Degree' type the name of your ICC qualification here are the official names for quick reference:
 - i. Global Trade Certificate (GTC)
 - ii. Certified Trade Finance Professional (CTFP)
 - iii. Export/Import Certificate (EIC)
 - iv. Incoterms® 2020 Certificate
 - v. Free Trade Agreement Certificate (FTAC)
 - vi. E-Invoicing Solutions Certificate (ESC)
 - vii. NVOCC Bill of Lading Certificate (NBL)
 - viii. Microfinance Associate Certificate (MAC)
 - ix. ICC Code for Ethical Marketing and Advertising (EMA)
- c. Under 'Field of Study' type one of the following 3 options:
 - i. Trade Finance for GTC, CTFP graduates
 - ii. International Trade for EIC, Incoterms[®] 2020, FTAC, ESC and MAC graduates
 - iii. Regulation and Compliance for MAC and NBL graduates
- **d.** Under 'Start Year' put the year you first got access to the course and under 'End Year' put the year you passed the exam
- e. Leave 'Grade' and 'Activities and Societies' blank



- f. Under 'Description' you can use the description below.
