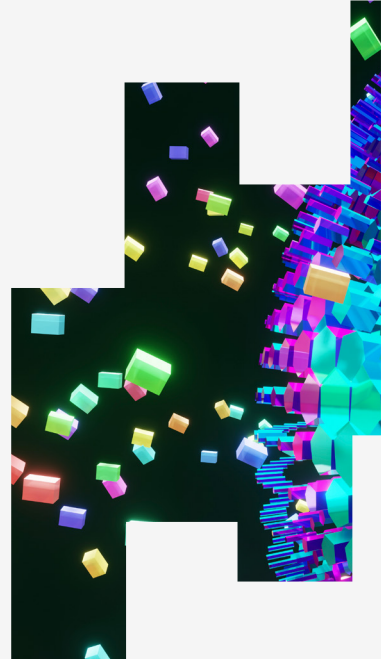

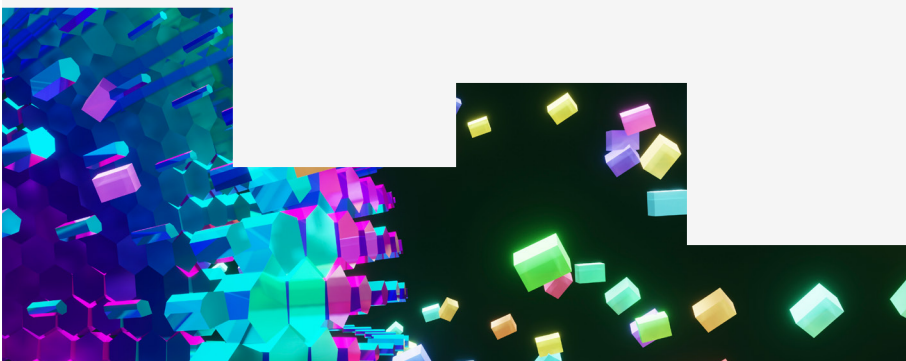

Certificate structure

This certification course includes six months access to 21 hours of online learning spread over 7 lessons and a 1-hour final, online exam:

- **Lesson 1:** Fundamentals of factoring
- **Lesson 2:** International factoring
- **Lesson 3:** Reverse factoring / supply chain finance
- **Lesson 4:** Operational aspects of factoring
- **Lesson 5:** Seller, buyer, import factor, credit insurance management
- **Lesson 6:** Legal and accounting aspects of factoring
- **Lesson 7:** Selling skills and risk mitigation
- **Final exam:** 1-hour online, live-proctored exam with 50 questions. Pass mark is 80%.

Recertification and CPDs

How the exam works

- Once you have completed all seven lessons, you will be able to access the final, online exam.
- The exam consists of multiple-choice questions and lasts for 1 hour. The passing mark is 80%.
- You must complete the exam within your 6-month access period.
- Your purchase of the CFaP includes one attempt at the exam. Subsequent attempts can be purchased for US\$100 if you are still within your 6-month access period.
- If you pass the exam, you will be awarded a digital, internationally recognised, ICC certificate of achievement.
